ADMISSIONS POLICY

St Peter's is a Voluntary Aided Catholic Secondary School, catering for students aged 11 – 18, and was established by the Catholic Diocese of Arundel and Brighton. The Governors aim to offer a Catholic education and the ethos of this school is founded on the Catholic faith. The Governors ask all parents/carers applying for a place here to respect this ethos and its importance to the school community. This does not affect the rights of parents/carers who are not Catholics to apply for and be considered for a place.

The school has an agreed capacity of **175 students** in Year 12. The Published Admissions Number (PAN) for external applicants is **25**.

Internal applicants will automatically progress onto Sixth Form as long as they meet the minimum grade entry requirements.

If there are more than **25** external applications received who all meet the minimum entry requirements, those external places will be allocated according to the following categories, proportions and priorities in line with the Diocesan and Catholic Education Service policy, statutory regulation and guidance:

- 1. Baptised Catholic looked after or previously looked after children**
- 2. Baptised Catholic children who have exceptional medical, social, compassionate or family needs**
- 3. Other baptised Catholic children**
- 4. Other looked after or previously looked after children**
- 5. Children of other faiths**
- 6. Any other children**

YEAR 12 ENTRY REQUIREMENTS

For an Academic, Combined Academic and Vocational or Vocational Pathway at Level 3 consisting of 4/5 AS subjects or a combination of BTEC & AS, or BTEC only

Five individual GCSE grades A* – C in any subject, including English and Maths. Students must additionally meet the individual subject specific criteria as published in the Sixth Form prospectus, which includes GCSE grade A for Maths, Sciences and MFL or an A* for Further Mathematics.

YEAR 13 ENTRY REQUIREMENTS

The entry requirements for Progression from Year 12 into Year 13 are a minimum of four D grades or equivalent in AS Levels or BTEC. A grade D or above is required in each subject to progress from AS to A2 Level. The requirement for students to be following a full time course is three A2 levels/BTEC equivalents.

PROCEDURES FOR ADMISSION

External students are required to complete a formal application and this must be submitted before the published closing date. A meeting will be conducted in the spring term with all applicants to discuss options and courses but that this meeting does not form part of the decision making process with regards to admissions.

Governors will assess all external applicants in order of priority for admission under the Sixth Form Admissions Policy. The Governors are the admissions authority for the school and are responsible for deciding the order of priority for admissions to the school.

Once the criteria have been applied, a maximum of **25** external students will be made a provisional offer, subject to meeting the entry requirements for their programme of study by 1st September on Year on Entry. A waiting list will be formed if the number of applications exceeds **25**. Students will enrol on their courses in September once they have met the terms of their provisional offer.

DEFINITIONS

Looked After Children

'Looked after children' are children who are registered as being in the care of the LA or provided with accommodation by a LA in accordance with Section 22 of the Children Act 1989(a) e.g. fostered or living in a children's home, at the time an application for a school is made. **'Previously looked after children'** means such children who have previously been in the care of a LA or provided with accommodation by a LA in accordance with Section 22 of the Children Act 1989(a) and who have left that care through adoption, a 'child arrangement order' (in accordance with Section 8 of the Children Act 1989 as amended by the Children and Families Act 2014) or special guardianship order (in accordance with Section 14A of the Children Act 1989).

Baptised Catholic

'Baptised Catholic' describes a member whose Church of Baptism is 'in communion with the See of Rome'. The Catholic Church comprises within it the Latin Rite (Roman Catholics) and Catholics from the Eastern or Oriental Rite. This will be evidenced by a Certificate of Baptism in a Catholic Church or a Certificate of Reception into Full Communion with the Catholic Church.

<u>Eastern or Oriental Rite Catholic Churches in Full Communion with Rome</u>	
ALEXANDRIAN	Coptic, Ethiopian (Gheez)
ANTIOCHIAN	Malankrese, Maronite, Syrian
ARMENIAN	Armenian
CHALDEAN (EAST SYRIAN)	Chaldean, Syro-Malabar
CONSTANTINOPOLITAN (BYZANTINE)	Albanian, Belarusian, Bulgarian, Georgian, Greek (Hellenic), Greek-Melkite, Hungarian, Italo-Albanian, Krizevci, Macedonian, Romanian, Russian, Ruthenian, Slovak (Greek), Ukrainian (Greek)

Note 1. Eastern Orthodox Churches, including the Coptic Orthodox, Greek Orthodox and Russian Orthodox Churches, are NOT in full communion with the See of Rome.

Note 2. Ordinariates are members of the Latin Rite

Note 3. Anglicans describing themselves as 'Anglo Catholics' are members of the Anglican Communion and therefore not in communion with the Holy See.
