Acceptable Use Agreement Sixth Form

The aim of this policy is to ensure:

-that all students will be responsible users who stay safe while using the internet and other communications technologies.

-that school ICT systems and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk.

General School Rules Apply to all use of ICT equipment and rooms.

Acceptable Use Policy Agreement

I understand that I must use school ICT equipment in a responsible manner to ensure there is no risk to my or other users' safety or the safety and security of the ICT systems. I understand that the use of the equipment provided is for educational purposes only.

For my own personal safety:

- I understand that the school will monitor my use of the ICT systems, email and other digital communications and agree that I will not access or store any unsuitable or prohibited data of any sort.

-I will not share my password, nor will I try to use any other person's username and password.

- I will immediately report any unpleasant or inappropriate material or messages or anything that makes me feel uncomfortable when I see it online.

I understand that everyone has equal rights to use technology as a resource and

- I understand that the school ICT systems are intended for educational use and I will not use the systems for personal or recreational use.

- I will not try to make large downloads or uploads that might take up internet capacity and prevent other users from being able to carry out their work satisfactorily.

- I will not attempt to use the school ICT systems for on-line gaming, on-line gambling, internet shopping, file sharing or video broadcasting (eg You Tube).

- I will act as I expect others to act towards me.

- I will respect others work and property and will not access, copy, remove or otherwise alter any other user's files.

- I will not take or distribute images of anyone without their permission.

I recognise that I have a responsibility to assist the school in maintaining the security and integrity of the technology it offers to me by my actions.

- I will not attempt to connect any personal devices to school equipment or the network without the prior permission of a member of the ICT staff (including but not restricted to mobile phones, MP3 players, cameras etc.).

- I understand the risks and will not try to upload, download or access any materials which are illegal or inappropriate or may cause harm or distress to others, nor will I try to use programmes, software or websites that might allow me to bypass the filtering or security systems in place to prevent access to such materials.

- I will immediately report any damage or faults involving equipment or software, however this may have been caused.

- I will not open any attachments to emails, unless I know and trust the person / organisation who sent the email, due to the risk of the attachment containing viruses or other harmful programmes.


- I will not attempt to install programmes of any type on a machine or store programmes on an individual computer, nor will I try to alter any computer setting.

When using the internet I will abide by all regulations relating to copyright and ensure I have permission before using the original work of others.

-I understand that I am responsible for my actions both in and out of school.

- I understand that the school has the right to take action against me if I am involved in incidents of inappropriate behaviour, that are covered by this agreement, when I am out of school and where they involve my membership of the school community.

- I understand that failure to abide by this agreement will lead to disciplinary action in accordance with the schools standard disciplinary procedures.
